15. The Settler – cum- Chairman shall preside at all meeting of the trust, when he is present and shall exercise such other powers as are conferred upon him by these rules, the Settler – cum- Chairman may call for an emergency meeting through Settler – cum- Chairman signed notice in a shorter period.

The decision of Settler - cum- Chairman that a resolution has been carried or lost shall be conclusive, unless such a decision is challenged and a poll is demanded, on poll being demanded, the same shall be taken in such manner as the Settler - cum- Chairman may in discretion determine. In case of a tie the Settler - cum- Chairman shall have a second or casting vote.

- (a) He shall be in charge of the office and shall be responsible to general body in all matters. He will contract in all ways and means of the position of the association and shall have right to improve it.
- (b) He shall be convener of all the meetings and without his signature on the notice of meetings no meetings will be valid.
- (c) It shall be his duty to see that the resolution at the respective meeting are implemented and give to effect to timely.
- (d) He shall be at liberty to spend for the purpose of the trustee without sanction of the Settler - cum- Chairman to do all such other lawful notes, deeds of things as incidental or conducive to the attachment of trustee.
- (e) He/ She will be responsible to general body in all matter. He/She will contract in all ways and means of the position of the association and shall have right to improve it.
- (f) He/Se shall produce the accounts of the Trust before Executive Committee for approval.
